#### SCOPE OF APPLICATION

PALACE LIQ is suitable for all floor, staircase and wall coverings, made of natural and artificial stone, such as marble, limestone, Solenhofer slabs, travertine, slate, granite, terrazzo, artificial stone, agglomerate marble, composite materials, cotto, brick, clay and clinker coverings, unglazed tiles, etc.

Also suitable for painted surfaces and plastics in the kitchen.

#### APPLICATION

For manual cleaning with a flat mop or floor scouring cloth, add approx. 25 to 50 ml in 10 l warm water. When using PALACE LIQ floor cleaning machines, dilute with warm water first. After cleaning the surfaces, avoid wiping them with water so that care components are retained. Increase the dosage slightly on first use, especially on absorbent surfaces.

#### CONTENTS MATERIALS

N,N-bis(hydroxyethyl)cocosamide, 5-15% non-ionic surfactants, fragrances, limonene, citral, linalool, citronellol, methylisothiazolinones, benzisothiazolinones.
