



DEEP CLEAN ME - ABRASIV

DEEP CLEANER FOR ANODIZED ALUMINIUM

FEATURES

Removes heavy soiling, iridescence, oil, grease and pigment stains, rain drains and rust from metallic surfaces. The anodised layer will not be damaged if used properly.

APPLICATION AREA

For cleaning anodised aluminium. Not suitable for metals such as copper, brass, stainless steel, chrome-plated surfaces, zinc, etc.

APPLICATION

Light to medium contamination:

- It is always used pure.
- Is well processed with facade pad brown.
- It is sufficient to rinse with clear water for light soiling, DEEP CLEAN ME - ABRASIV should be applied directly to moist surfaces.
- Dry or wipe off the surface.

Strong oiling and iridescence:

- Easy pre-cleaning with CLEANER ME/PL NEUTRAL 1:5 and facade pad brown.
- Apply the deep cleaner directly to the slightly damp surfaces and repeat the procedure 2-3 times (depending on the degree of soiling).
- Make sure that the surfaces are kept lightly moist.



Further operation after cleaning with DEEP CLEAN ME - ABRASIV:

- After deep cleaning, rinse again with water, possibly with the help of a sponge or a washing brush.
- Dry or wipe, especially in joint and edge areas. Blow off areas with compressed air to avoid draining.

Please note:

- Do not use in direct sunlight.
- In case of large amount of dirty water, this must be collected with a foil tray and disposed separately. Check with the competent waste water authority.
- Pad sponges are unsuitable.

Recommended: After cleaning, conserve the surface. Storage max.
