PROPERTIES

FOAMEX-DRY brings back the original cleanliness of carpets. With a high-yield foam formula, the dirt is pulled out of the carpet fibers. Does not leave adhesive residues on the fibers. Low-moisture foam Accelerates drying time. Suitable for single disc machines or dry shampooers.

AREA OF APPLICATION

For shampooing all color- and water-resistant textile coverings, carpets and upholstered furniture made of natural and synthetic fibers. Crystallized dirt residues can be easily vacuumed off. Does not leave residues that promote resoiling.

APPLICATION

1. remove all furniture from the surface to be cleaned. Vacuum the surface carefully.
2. treat all stains with SPOTEX stain remover.
3. in case of heavy soiling, carry out a pre-treatment with PRETEX pre-cleaner.

Dry foam shampooing:

1. normal soiling with 1:24 and heavy soiling with dilute with 1:12 warm water.
2. shampoo the carpet according to the instructions for the machine.
3. allow the carpet to dry (approximately 1-2 hours). Before vacuum again before re-walking, if possible with a brush vacuum.

Machine cleaning

:Depending on the degree of soiling, dose 300-500 ml to 10 liters of water. Pour this shampoo liquid into the cleaning tank of the machine. Shampoo with the single-disc machine and a suitable pad or brush, section by section and crosswise. Pick up the dirt liquor with water suction. In extreme cases, it is advisable to extract deposit with clear water. Vacuum again before re-walking.

- **Type:** synthetic detergent
- **Form:** liquid
- **Fragrance:** citrus
- **Color:** transparent
- **Drying time:** about 2 hours
- **Foaming:** very strong

Notice:

Before the first application the carpet on an inconspicuous check the color fastness of the carpet in an inconspicuous place.
