PROPERTIES

IDEAL is a special cleaning agent concentrate for fine stoneware and safety tiles. Can be used as a basic cleaner as well as a maintenance cleaner. Easily removes even stubborn, oily and greasy dirt. Cleans deep into the pores, thoroughly and intensively.

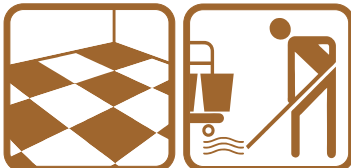
APPLICATION AREAS

Suitable for all waterproof and alkali-resistant floor coverings, especially ceramic tiles and alkali-insensitive stone coverings. For manual and machine cleaning. Check material compatibility in advance. We accept no liability for damage caused by improper use.

APPLICATION

Mechanical basic cleaning: Dilute IDEAL 10 % with cold, clear water. (1 part IDEAL to 9 parts water). Pre-water the floor covering incl. joint material with plenty of cold water. Then apply plenty of cleaner solution to the floor (500 - 650 ml application solution/m²). Reaction time approx. 5 minutes. Keep the liquor moving manually or mechanically during the application time. After the exposure time, use a single-disc machine with a suitable pad/brush to remove the entire floor covering and thoroughly vacuum the treated floor surface. Rinse the floor thoroughly (several times if necessary) with clean water and vacuum again. Remove dissolved residues from the surface by wiping with clear water - if necessary, rinse the surface and remove with a water vacuum cleaner.

Routine cleaning: Prepare IDEAL 0.25 - 5.0 % application solution. Apply with a scrubber-dryer or manually in a 2-stage wet wiping procedure.
